CONSTITUTION OF INDIA.

No. RCT 1030/CR-366-E-7 :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all existing rules, orders and instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Aval karkan (Class III) in the Revenue Department.

1. (i) These rules may be called the Maharashtra Revenue Department Aval karkan (Recruitment) Rules, 1936;

(ii) They shall come into force with effect from 1st February 1936.

2. In these rules, unless the context requires otherwise :-

(a) "Aval karkan" includes Circle Officer, Treasury Aval karkan, Deputy Chitnia, Second Clerk to the Collector, Shirnatedi, First Grade Clerk and Senior Clerk;

(b) "Circle Inspector" means the holder of the post of Circle Inspector in Konkan Division, Nashik Division, Pune Division and Aurangabad Division;

(c) "Circle Officer" means the holder of the post of Circle Officer in Konkan Division, Nashik Division and Pune Division.

(d) "Collector" means the Collector of a District appointed under section 7 of the Maharashtra Land Revenue Code, 1906;

(e) "First Grade Clerk" means the holder of the post of First Grade Clerk in Nagpur Division and Amravati Division;

(f) "Qualified person" means a person who has passed or who has been exempted from passing the Revenue Qualifying Examn.

(g) "Revenue Inspector" means a person holding a post of Revenue Inspector in Nagpur Division and Amravati Division;

(h) "Revenue Qualifying Examination" means the Examination prescribed for the promotion of a person from the cadres of Clerk, Revenue Inspector or Circle Inspector to the post of Aval karkan or any such examinations, as may be prescribed by Government for the purpose from time to time;

(i) "Senior Clerk" means the holder of a post of Senior Clerk in the Office of the Collector of Bombay.

3. Appointment to the post of Aval karkan shall be made by promotion, on the basis of seniority, subject to fitness, from amongst the qualified persons holding the post in the cadre of Clerk or Revenue Inspector or Circle Inspector;

Provided that, the proportion in which persons from the cadres of Clerk, Revenue Inspector or Circle Inspector are to be promoted, shall be determined for each district by the Commissioner of the respective Division, after considering the strength of each cadre ;

Provided further that, the proportion so fixed under the first proviso shall be reviewed by the Commissioner once in ~~the~~ three years.

4. The cadre of Aval karkun shall be a district cadre and persons from this cadre shall be transferrable anywhere in the district.

5. The Collector shall be the appointing authority in respect of the cadre of Aval karkun in each district.
