Maharashtra Agricultural Lands (Ceiling on Holdings) Act, 1961. Management of Sugar Factory Farms ... under section 28 of -

Read: Government Resolution, Revenue Department, No.ICH.1662/ 12819-M(Spl), dated 30th August 1962.

Letter from the Officer on Special Duty, No. CING/WS/169/ 1962, dated 12th October 1962 and its accompaniment.

Resolution: Government is pleased to direct that pending finalisation of the proposals to set up a Government owned Company to manage the Sugar Factory Farms vesting in Government under the Maharashtra Agricultural Lands (Ceiling on Holdings) Act, 1961, the establishment of the Officer on Special Duty, Revenue-Department, Poona (last sanctioned upto 28th February 1963) Department, Poona (last sanctioned upto 28th February under Government Resolution, Revenue Department, No.1CH.1662/12819-M(Spl), dated 30th August 1962) should be re-organised with effect from 1st December 1962, and should be entrusted with the work of making all preliminary arrangements for management of sugar-cane farms e.g. working out cropping pattern, obtaining detailed information about technical and other staff at present employed on the farms etc.

2. The re-organised office of the Officer on Special Duty, in addition to the staff sanctioned in the Government Resolution, dated 30th August 1962, should include the following

The above additional staff should be sanctioned for the period ending 28th February 1963 with effect from the date(s) of appointment. The Officer on Special Duty should however, informed.

- 3. Sanction is also accorded to the purchase of one new Station Wagon for the use of the Officer on Special Duty and the Plantation Expert.
- 4. Government is pleased to direct that Shri-S.C. Chaudhary should be appointed to the post of Plantation Expert and his pay should be fixed at Rs. 2.700/- (Rupees two thousand seven hundred) per month. Shri Chaudhary should also be allowed other facilities such as free accommodation and transport etc. which he might be enjoying in his present employment with the Maharashtra Sugar Mills Ltd., Tilaknagar. The period of the service contract with Shri Chaudhary should be fixed and other terms specifically settled, to avoid any disputes in the future. The Officer on Special Duty should be requested to submit necessary proposals in that behalf, for approval of Government.
- An ad hoc grant of Rs. 45,000/- is hereby placed at the disposal of the Officer on Special Duty to meet the cost on his entire establishment with effect from 1st December 1962 onwards and for meeting the cost of purchase of a Station Wagon, furniture hire and other contingent expenditure.
- 6. Government is also pleased to declare the Officer on Special Duty, Revenue Department, Poona, as head of the Department for all purposes.
- 7. The Officer on Special Duty should also be requested to work out the requirements of his office in regard to stationery, furniture, rent for the office building and other contingent expenditure and should submit revised and detailed proposals for approval of Government. Till then, if necessary, minimum necessary furniture may be hired at local rates paid by other Government Offices.
- 8. As the re-organised office of the Officer on Special Duty set up under this Government Resolution is to make preliminary arrangements in respect of the management of the sugar-factory farms, Government is pleased to direct that the expenditure incurred on the said establishment till it is actually transferred to the Government owned Company to be established for the management

of.

of the farms, should be recovered from the Company after it is set up.

The expenditure should be debited to the budget head "19-General Administration-Q-General Establishment-Q.1.-District Establishment" and met from the advance of Rs. 45,000/-from the Contingency Fund sanctioned under Government Memorandum, Finance Department, No. CNF.1162/XVII, dated 28th November 1962. A supplementary demand should be presented to the Legislature in its next session. The Officer on Special Duty, Revenue Department, Poona, should be requested to follow the procedure laid down in rule 6 of the Contingency Fund Rules, 1957, and report to Government in the Finance Department and Revenue Department every month the expenditure incurred from this advance from the Contingency Fund.

10. This Government Resolution issues with the concurrence of the Finance Department vide its u.o.r. No. 1793/XVII, dated 28th November 1962.
