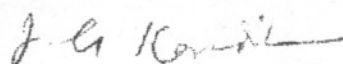
RESOLUTION:- The draft of the Maharashtra Agricultural Lands (Ceiling on Holdings) Compensation Bond (Amendment) Rules 1963 was published under Government Resolution, Revenue Department, No. ICH.1161/21418-M(Spl), dated 22nd August 1963. No suggestions or objections in respect of the said draft Rules have been received by Government from the members of the Public. The draft Rules should, therefore, be published finally, in part IV-B of the Maharashtra Government Gazette, Extraordinary, dated 9th October 1963.

2. The Director of Publicity should give wide publicity to the notification in the whole State.
3. The Translation Bureau of the Law and Judiciary Department should be requested to translate the notification in Marathi and Hindi and forward the translations to the Directors, Government Printing and Stationery. The Director should publish the translations in the Maharashtra Government Gazette and supply their copies as well as copies of the notification in English to the Collectors and other officers according to the distribution list appended to this resolution. The Director should also keep sufficient number of copies of the notification in English and regional languages for sale to the members of the public.

MAHARASHTRA AGRICULTURAL LANDS (CEILING ON HOLDINGS) ACT, 1961.

No. ICH. 1161/21418-M-(Spl.).—In exercise of the powers conferred by sub-section (1) and clause (g) of sub-section (2) of section 46 read with section 26 of the Maharashtra Agricultural Lands (Ceiling on Holdings) Act, 1961 (Mah. XXVII of 1961), and of all other powers enabling it in that behalf, the Government of Maharashtra hereby makes the following rules, the draft of the same having been previously published as required by sub-section (1) of section 46, namely :—

1. These rules may be called the Maharashtra Agricultural Lands (Ceiling on Holdings) Compensation Bond (Amendment) Rules, 1963.

2. In the Maharashtra Agricultural Lands (Ceiling on Holdings) Compensation Bond Rules, 1962 (hereinafter referred to as "the principal rules") in Table No. VI, in Form "D", in the entry relating to the 9th year, under the heading "Interest" for the figures "100.26" the figures "100.36" shall be substituted.

3. For form "E" appended to the principal rules the following shall be substituted, namely :—
