CIRCULAR OF GOVERNMENT

In Government Resolution No. LND. 1071/275810-A-II dated 30th December 1971 as amended from time to time, Government has directed the Collectors that the members of the Armed Forces and the Border Security Forces from Maharashtra State, who have received awards for gallantry in the recent Indo-Pak Conflict, should be granted lands for cultivation and residence. A point has been raised whether the Defence Personnel who have been "mentioned in the Military despatches" should be held eligible for the grant of the above concession. Government has already decided in Government Resolution Home Department (Special) No. SB.II/AGF 1971/26320, dated 31st December 1971 that the following categories of decorations instituted by the Government of India, should be treated as 'gallantry awards' for the purposes of grant of cash allowances by the Maharashtra State:-

Name of the decoration

1) Param Vir Chakra. 2) Maha Vir Chakra 3) Vir Chakra  
4) Sena Medal. 5) \*

5) Those whose names have been specifically mentioned in the Military despatches. Government is pleased to direct that for the purposes of grant of land for cultivation and residence, the above mentioned decorations should be treated as 'gallantry awards' and the persons who have received the same, should be granted lands in accordance with the orders issued in Government Resolution dated 30th December 1971 as amended from time to time.
