BOMBAY VILLAGE PANCHAYATS ACT, 1958.

No. VPA. 1171/5191-El.—The following draft of rules further to amend the Bombay District Village Development Fund Rules, 1960, which the Government of Maharashtra proposes to make in exercise of the powers conferred by clause (xxxvi) of sub-section (2) of section 176 read with section 133 of the Bombay Village Panchayats Act, 1958 (Bom. III of 1959), and of all other powers enabling it in that behalf, is published as required by sub-section (4) of the said section 176, for the information of all persons likely to be affected thereby; and notice is hereby given that the said draft will be taken into consideration by the Government of Maharashtra on or after the 7th day of May 1972.

2. Any objections or suggestions which may be received by the Secretary to the Government of Maharashtra in the Rural Development Department from any person with respect to the said draft before the aforesaid date will be considered by Government.

DRAFT RULES

1. These rules may be called the Bombay District Village Development Fund (Amendment) Rules, 1972.

2. In the Bombay District Village Development Fund Rules, 1960 (hereinafter referred to as "the principal rules"), in rule 6, for sub-rule (3), the following sub-rule shall be substituted, namely:—

"(3) The Standing Committee may, with the sanction of the Commissioner, incur expenditure from out of the fund on staff engaged for operating the fund and on all charges incidental thereto, such as, printing, stationery, stamps and the like, and such expenditure shall be debited to the fund."

3. In rule 11 of the principal rules, for clause (iii), the following shall be substituted, namely:—
"(iii) making such enquiry as it deems fit, grant to the Panchayat loan from out of the fund of an amount not exceeding 75 per cent. of the estimated cost of the work for which the loan is required:

Provided that—

- the amount of the loan is available from the fund;
- the total amount of loans advanced to panchayats from out of the fund in a financial year does not exceed three-fourths of the balance to the credit of the fund on the date the loan is sanctioned;
- the amount of loan does not exceed Rs. 30,000; and
- where the amount of loan exceeds Rs. 30,000,

Parishad has given its previous approval to the grant of loans."
