C I R C U L A R

The Government in Home Department has already issued a Circular, dated the 15th March, 1995 (copy enclosed) instructing the District Magistrates/Superintendents of Police/Commissioners of Police to report to National Human Rights Commission the incidents of deaths in Custody within 24 hrs. of its occurrence. These instructions were reiterated under Government Circular, Home Department, No. HRC. 1095/41-POL. 14, dated 17th January, 1996 a copy of which is enclosed. These instructions are again brought to the notice of all the concerned officers.

2. Now the National Human Rights Commission has desired to have the information about the occurrence of deaths and rapes in Juvenile homes as well as other homes run under different statutes. These could cover the following institutions :-

(I) Set up under Juvenile Justice Act, 1986 :

1. Observation Home

2. Juvenile Homes

3. Special Homes.

(II) Set up under Probation of Offenders Act, 1958 :

1. Probation Homes.

(III) Set up under Immoral Traffic (Prevention) Act,

1. Reception Centres

2. Short Stay Homes

3. Nari Niketan/After Care Home.

(IV) Set up under Prevention of Beggars/Begging Act :

1. Reception Centres
2. Beggars Home

(V) Set up under Borstal Act :

1. Borstal Institution.

3. In view of the para. 2 of the above, all District Magistrates, all Commissioners of Police and all Superintendents of Police are hereby directed to report to the Secretary General of the National Human Rights Commission about the incidents of deaths and rapes occurring in the above mentioned homes/institutions, within 24 hrs. of occurrence or of the offence having come to be known about such incident. Failure to report promptly would give rise to presumption that there was an attempt to suppress the incident.

4. To enable the concerned District Magistrate, Commissioner of Police and Superintendent of Police to send the report of such incidents to the Commission within stipulated time, the officer-in-charge of the above mentioned homes/institutions should send at-once the information of incidents of deaths and rapes in the homes/institutions under their control to the concerned District Magistrate/Commissioner of Police and Superintendent of Police giving ample time for the District Magistrate /Commissioner of Police and Superintendent of Police for sending the reports to the Secretary General of the Commission within 24 hrs. of its occurrence. You are, therefore, requested to bring this circular to the notice of all concerned and to direct them to send the report of such incidents to the concerned District Magistrate/Commissioner of Police and Superintendent of Police at-once.
